The undersigned, pursuant to Section 607.1006 (1995) of the Florida Business Corporation Act, hereby executes the following Articles of Amendment to Articles of Incorporation of the above-named corporation, which Articles of Incorporation were filed with the Department of State on April 5, 1979, Charter # 616510, as follows:

1. The name of the corporation in Articles of Incorporation which are hereby amended is LoRICCO, WILLIAMS, WUNDER AND CROSLAND, C.P.A.'s, P.A.

2. Article 1 on Page 1 of the Articles of Incorporation of the above-named corporation is hereby revoked, effective January 15, 1998, and the following is substituted in its place:

"ARTICLE I

The name of this corporation is

LoRICCO, WILLIAMS, CROSLAND, SANDLES AND JOINER, C.P.A.'s, P.A.

3. The foregoing Amendment was adopted by the shareholders of the corporation, in accordance with Section 607.1003 (1995), Florida Statutes, on December 30, 1997. The outstanding share certificates of this corporation shall be exchanged for share certificates bearing the new name of the corporation which certificates shall set forth the same number of shares as the currently issued share certificates.

4. The right to amend or revoke the foregoing Articles of Amendment to Articles of Incorporation of the said corporation in whole or in part is hereby reserved.

5. In every other respect I hereby confirm and republish the said Articles of Incorporation as filed with the Department of State on April 5, 1979.

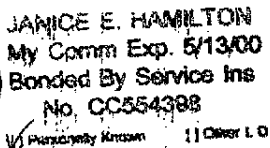

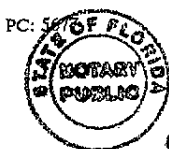

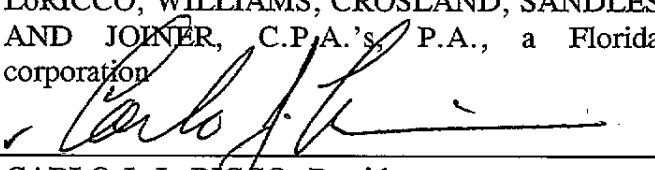
