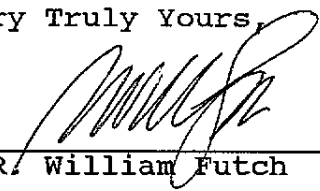

5. All liabilities and obligations of the Corporation have been paid or discharged.

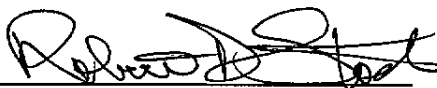

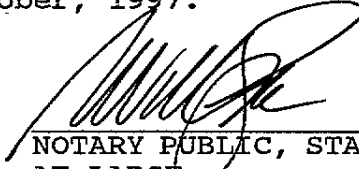
