ARTICLES OF DISSOLUTION

The undersigned, being the President and Secretary of David Hendel Associates, Inc., a corporation organized under the laws of the State of Florida, hereby adopts and files the following Articles of Dissolution pursuant to Section 607.1403 of the Florida Business Corporation Act.

ARTICLE I
