The undersigned, being the president and the secretary of SUN BELT PRECISION PRODUCTS, INC., do hereby certify and set forth:

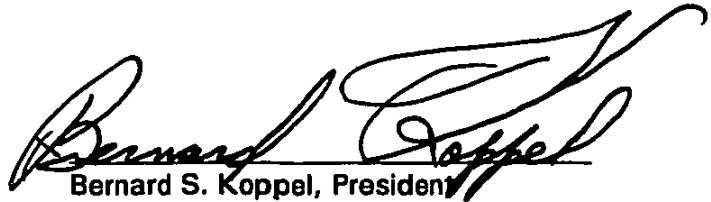
1. The name of the corporation is SUN BELT PRECISION PRODUCTS, INC.

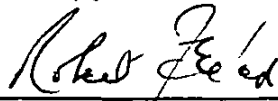
