

Dear Steve:

Thank you for sending me the applications for reinstatement. In accordance with our telephone conversation last week, I am enclosing the Application for Reinstatement for two corporations that I own: Mendelsohn Enterprises, Inc. and Mendelsohn Trading Corporation. I am also enclosing two checks each in the amount of \$965.00 to reinstate these two corporations and bring them up-to-date through 1997.

You had indicated to me after speaking to your supervisor that you would waive the reinstatement fees since the reason that I had not been paying these bills is because Pasco County changed the name of my street address and I never received the notices and reminders pertaining to annual reports due for these two companies.

I am also enclosing Articles of Amendment to the Articles of Incorporation for Mendelsohn Enterprises, Inc. which I had previously sent to the Department of State on January 2, 1997, which were returned to me on January 14, 1997 by Karen Gibson (Letter Number: 597A00001886) due to the dissolution of this corporation due to non-payment of its annual fees. I would appreciate if you would reinstate these two corporations and process the enclosed Articles of Amendment to the Articles of Incorporation for Mendelsohn Enterprises, Inc. changing its name to Market Technologies Corporation.

I very much appreciate the fact that you agreed to waive the reinstatement fee due to the circumstances regarding the change in the name of my street address and the fact that I never received any of the notices prior to the dissolution of these corporations, which have continued to file all other required state tax returns annually.
