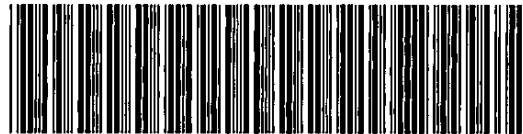

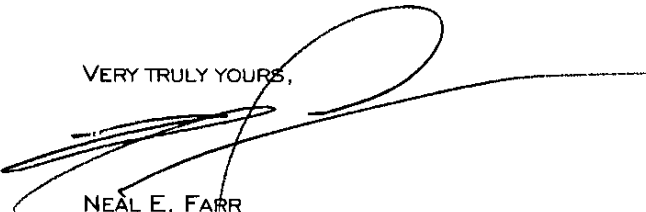

ARTICLE I

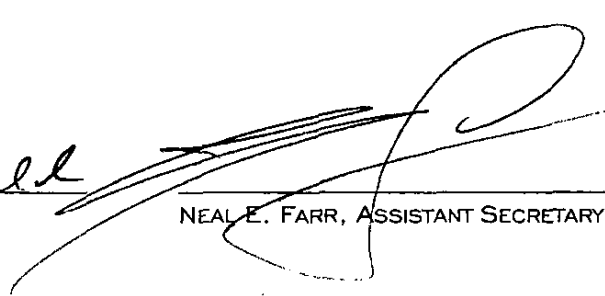
THE NAME OF THE CORPORATION SHALL BE BULLET ONE, INC.
