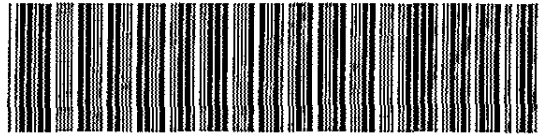

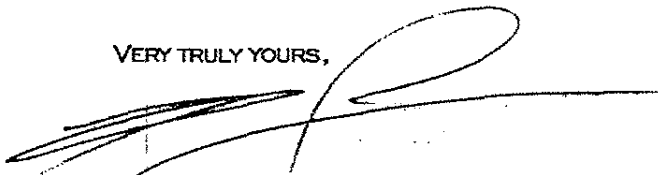

ARTICLE I

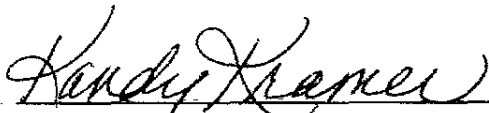
THE NAME OF THE CORPORATION SHALL BE BULLET LINE, INC.
