ARTICLES OF AMENDMENT TO THE AMENDED AND RESTATED ARTICLES OF INCORPORATION OF BFC FINANCIAL CORPORATION

The Amended and Restated Articles of Incorporation, as amended, of BFC Financial Corporation, a Florida corporation (the "Corporation"), are hereby amended pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, and such amendments are set forth as follows:

- 1. The first sentence of the second paragraph of Article IV is hereby deleted in its entirety and replaced with the following:
 - "Special Class A Common Stock. The Corporation is authorized to issue 150,000,000 shares of Special Class A Common Stock at a par value of \$.01 per share."
- 2. The first paragraph of Section 6 of Article V is hereby deleted in its entirety and replaced with the following:
 - "1. Designation and Amount. The shares of such series shall be designated "Class A Common Stock" (the "Class A Common Stock") and the number of shares constituting such series shall be 150,000,000."



The undersigned hereby certifies that the foregoing amendments were duly adopted and approved by the board of directors of the Corporation on July 2, 2009 and by the holders of the Corporation's Class A Common Stock and Class B Common Stock, voting together as a single class, on September 21, 2009, and that the number of votes cast for the amendments was sufficient for approval.
