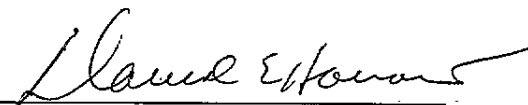

14th day of March, 2002.

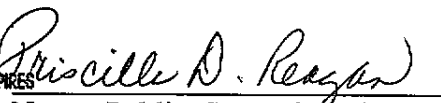
