14. The first part of the problem is to show that the function $f(x) = \frac{1}{x}$ is not continuous at $x = 0$. To do this, we need to show that there exists a $\delta > 0$ such that for any $\epsilon > 0$, there is an x with $0 < |x| < \delta$ and $|f(x) - f(0)| \geq \epsilon$. Since $f(0)$ is not defined, we can choose $\epsilon = 1$. Then, for any $\delta > 0$, we can choose $x = \delta/2$. Then $|f(x) - f(0)| = |f(x)| = \frac{1}{x} = \frac{2}{\delta} \geq 1 = \epsilon$. Therefore, $f(x)$ is not continuous at $x = 0$.
