ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION OF
CASH & ASSOCIATES, P.A.

FIRST: Pursuant to Section 607.1003 of the Florida Statutes, the Articles of Incorporation of Cash & Associates, P.A. are hereby amended as follows:

A. To replace the first paragraph of the Articles of Incorporation to read as follows:

"The undersigned, being of legal age and competent to contract for the purposes of organizing a corporation pursuant to Chapter 607 of the laws of the State of Florida, does hereby adopt the following Articles of Incorporation, and does hereby agree and certify as follows:"

B. To change Article I to read as follows:

"ARTICLE I

NAME AND PRINCIPAL ADDRESS

The name of this corporation shall be CASH & ASSOCIATES, INC. whose principal office shall be located at 1411 Edgewater Drive, Suite 100, Orlando, FL 32804."

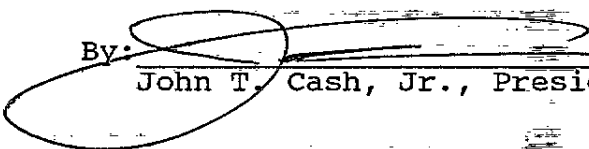
C. To delete any reference in the Articles of Incorporation to the name "Cash & Associates, P.A.", and replace all such references with the name "Cash & Associates, Inc."

SECOND: The foregoing Amendment was adopted by Shareholders representing all the shares and all Directors of Cash & Associates, P.A. on January 12, 1999 which manifests an intent to amend the Articles of Incorporation effective upon the filing of this Amendment with the Secretary of State.

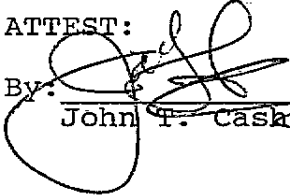
THIRD: Delete Article IX entirely and renumber succeeding Articles.

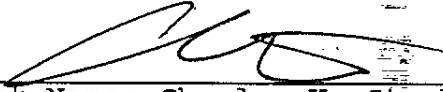
