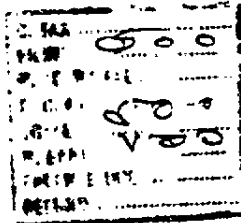



AMENDMENT NO. VIII TO DECLARATION OF TRUST

Orlando, Florida  
January 20, 1951

BE IT RESOLVED by the Board of Trustees of Lawyers' Title Guaranty Fund that Article VII, Section 2, Sub-section (a) 1. of the Declaration of Trust of Lawyers' Title Guaranty Fund (as same is on file with the Secretary of State of the State of Florida) be amended to read as follows:

1. (a) Member practicing alone - \$100.00; partnership of two - \$175.00; partnership of three - \$225.00; and \$25.00 for each partner in excess of three. No member shall be permitted to issue the Fund's guarantee or policy until such time as his initial contribution has been paid in full.

(b) Amounts designated in 1.(a) above may be increased by a resolution approved by a majority of the Board of Trustees and any increase thereof which have been promulgated prior to the effective date of this amendment are hereby ratified and confirmed.
