Pursuant to the provisions of Section 617.1002 of the Florida Statutes, the undersigned corporation not for profit adopts the following articles of amendment to its articles of incorporation:

1. The name of the corporation is PALM CHAPEL ASSEMBLY OF GOD, INC.
2. The following amendments of the articles of incorporation were adopted by the members of the corporation on February 21, 1995, in the manner prescribed by the Florida Corporations Not For Profit Act:

Article I is hereby amended to read as follows:

The name of the corporation (Assembly) shall be RIVER OF LIFE ASSEMBLY OF GOD, INC.

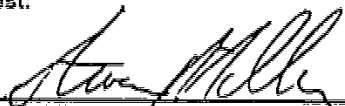
3. The number of members of the corporation at the time of such adoption was SIXTY-NINE (69); and the number of members entitled to vote thereon was SIXTY-NINE (69).

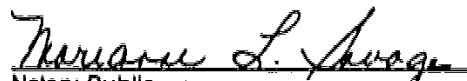
