## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF SARASOTA DAY NURSERY INC.

- Pursuant to Chapter 617 of the Florida Statutes, SARASOTA DAY
   NURSERY INC., a Florida not for profit corporation, hereby adopts the following Articles of Amendment to its Articles of Incorporation:
- 2. Article I of the Articles of Incorporation is hereby revoked and replaced with the following:

Article I. The name of the corporation shall be CHILDREN FIRST, INC. and its principal place of business shall be in Sarasota, Sarasota County, Florida.

- 3. The Amendment does not provide for an exchange, reclassification, or cancellation of issued shares.
- 4. The Amendment was adopted on the 27th day of January, 2000, by a vote of the members sufficient for approval in accordance with the corporation's Articles of Incorporation and Bylaws. Only one voting group was entitled to vote on the Amendment.
