

AMENDED ARTICLES

ARTICLES	Articles of Incorporation at Bible Church of God, Incorporated of Boynton Beach, Florida. We hereby associate ourselves together for the purpose of being Incorporated under the Laws of the State of Florida, applicable to corporation not for profit and respectfully pettion the Secretary of State for approval of such Incorporation under the following proposed Articles of Incorporation.
ARTICLES I NAME	The name of the corporation shall be Bible Church of God, Incorporated of Boynton Beach, Florida and its principle place of business shall be 1390 North Seacrest Blvd., Boynton Beach, Florida.
ARTICLES II PURPOSE	The General purpose and objective of the corporation shall be to conduct Religious Worship and Instruction, Churches, Schools and other institutions connected therewith of a Religious Education, Charitable and Benevolent. Character to end that its own members and others may be specifically instructed and guided concerning these Articles of Faith and to advance Spiritual Growth, enlightenment, moral and personal purity among its own membership and the people of the community in which it is located; and for the purpose of the aforementioned objectives. This corporation shall reserve the right to acquire either by gift or purchase, and to hold, own, sell, mortgage, or encumbering any manner. Lease and improve Real Estate and Personal Property for itself and other, either as trustee or otherwise, The Elders Council shall have final decision in ALL Financial matters concerning this Corporation. Said organization is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes the making of distributions to organizations that as exempt. Organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
	Upon the dissolution of the organization assets, shall be distributed for one or exempt purposes, including for such purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the Federal Government or to a State or local government, for a public purpose.
