

We, the undersigned, being the Board of Directors of Southwest Florida Center For The Handicapped, Inc., a Florida corporation, hereby certify that the following Amendment to the Articles of Incorporation was duly adopted by unanimous vote of the Board of Directors at a meeting duly held on the 24th day of April, 2001. No members are entitled to vote on the Amendment.

Effective August 1, 2001, the current Article I was deleted in its entirety, and the following substituted in its place:

ARTICLE I - NAME

THE LOVELAND CENTER, INC.

In all other respects, the Articles of Incorporation shall remain as they were prior to this Amendment being adopted.
