I am writing to reinstate our corporation, the Massachusetts Condominium Association, FEI Number 591201326.

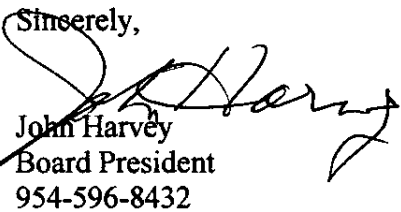
The reinstatement form is attached, and any questions can be directed to me, or to the Association's Treasurer, Ms. Houser.
