ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION

GREATER MIAMI BOWLING ASSOCIATION INC.  
(a nonprofit corporation)

Pursuant to the provisions of section 617.1006, Florida Statutes, this corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: ARTICLE II Be and the same is hereby amended to add as as (G) the following:

In furtherance of the foregoing objects, this association shall be conducted as a nonprofit organization, organized and operated at all times exclusively for charitable and educational purposes and, particularly, to foster regional, national and international bowling competition either directly or by contributions to organizations that are recognized as exempt from federal income taxation as organizations described in section 501(c) (3) of the Internal Revenue Code of 1986, as amended. In furtherance of the foregoing purposes, this association shall be organized and operated primarily to conduct or support bowling competition and to support or develop amateur bowling athletes for national or international competition within the meaning of section 501.(j) (2) of the Internal Revenue code of 1989 as amended.

SECOND: The following is adopted and added as article XII to the articles of incorporation, to wit:

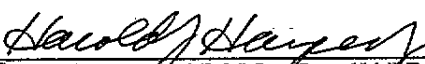
ARTICLE XII Dissolution

In the event that the Corporation shall be liquidated and dissolved, all of its assets remaining after payment and discharge of its duties, obligations and liabilities shall be distributed, in such proportion as the Board of Directors shall determine, to any organization or organizations, including trusts, organized and operated exclusively for charitable and educational purposes.

THIRD: The date of both amendments adoption was *November 9,* 1997.

FOURTH: These amendments were adopted by the Board of Directors on the date set forth in Paragraph Third above, by unanimous vote. No other members were entitled to vote on said amendment.
