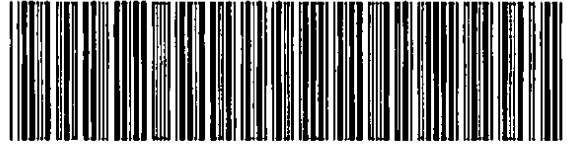

Pursuant to the provisions of section of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

**FIRST:** Article I is amended to read: "The name of the corporation shall be **United Way of St. Lucie and Okeechobee, Inc.**, and its office and places of business shall be located at such place or places in St. Lucie and/or Okeechobee Counties, Florida, as shall from time to time be designated by the Board of Directors".

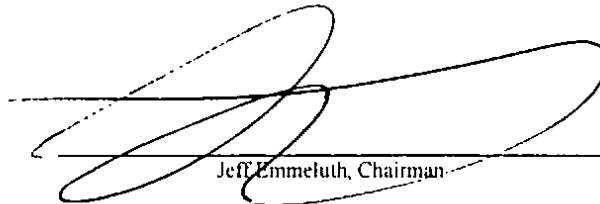
**SECOND:** Article VII is amended to read: "The members of the Board of Directors shall be elected in the manner prescribed by the bylaws".
