Resolution to Amend Charter

Resolved that the Charter (Articles of Incorporation) of the Georgiana Cemetery Perpetual Maintenance Fund, Inc. be amended as follows:

1. Substitute the following for ARTICLE III, QUALIFICATION OF MEMBERS:

"ARTICLE III. QUALIFICATION OF MEMBERS

Qualification of members and classes of membership shall be as set forth in the bylaws."

- 2. Modify the first sentence subparagraph (b) of ARTICLE XI, SPECIAL PROVISIONS as follows:
- "(b) All contributions made to the corporation shall be voluntary and shall be used for the purpose of paying only the necessary corporate expenses for the maintenance of the grounds, driveways, walkways, fences, and common areas of said cemetery...."
- 3. Modify subparagraph (e) of ARTICLE XI, SPECIAL PROVISIONS as follows:
- "(e) Any funds contributed to the corporation which are not required for immediate work to be done on the cemetery grounds may be deposited in banks or other financial institutions to the credit of the corporation, and any income received from the said deposits in the form of dividends or interest shall be added to the funds of the corporation, and used for the purposes and only for the purposes herein expressed."
- 4. Add new subparagraph (f) to ARTICLE XI, SPECIAL PROVISIONS as follows:
- "(f) In the event of dissolution, a plan for the distribution of assets shall be prepared per statute, adopted by the Board of Trustees, and be approved by a vote of members. All residual assets of the corporation shall be turned over to an organization engaged in activities substantially similar to those of Georgiana Cemetery Perpetual Maintenance Fund, Inc., as provided in the plan of dissolution."
