Dear Sir/Madam:

This is in response to your inquiry dated August 5, 1996, concerning your organization's tax-exempt status and its filing requirements.

In checking our records, we find that your organization may have been erroneously inactivated on the computer file we maintain for all tax-exempt organizations. To help us determine whether we have correct information on your status and to determine your current filing requirement, please check the appropriate boxes on the attached fact of filing response sheet and provide the returns or other information called for by your response. If you do not reply, you will continue to be listed as an inactive organization.

Our records indicate that your organization was recognized exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code (and determined to be a private foundation within the meaning of section 509(a), if applicable).

The following information on filing requirements may be helpful to you. Most organizations exempt from Federal income tax under section 501(a) of the Internal Revenue Code are required to file an annual information return Form 990, Return of Organization Exempt from Income Tax, if their annual gross receipts are normally more than \$25,000. For years ending before December 31, 1982, the filing minimum was \$10,000 of gross receipts. Generally, organizations classified as private foundations must file Form 990-PF, Return of Private Foundation, regardless of their gross receipts. However, a foundation will not be required to file such returns for any taxable year following the taxable year in which the last of any transfer of all its net assets occurred, if at no time during the subsequent taxable years in question the foundation has either legal or equitable title to any assets or engages in any activity.
