Articles of Amendment to the Certificate of Reincorporation of Sarasota Welfare Home, Inc.

98 SEP -4 M SECRETARY OF S TALLAHASSEE, FL

Sarasota Welfare Home, Inc., a Florida not-for-profit corporation, pursuant to the provisions of Section 617 of the Florida Not-for-Profit Corporation Act, adopts the following Articles of Amendment to it's Certificate of Reincorporation:

1. Article II of the Certificate of Reincorporation is amended to read as follows:

"The corporation shall be a not-for-profit charitable corporation within the meaning of Section 501(c)(3) of the 1954 Internal Revenue Code, as amended, primarily concerned with accumulating a fund for the construction of buildings and to maintain and operate same as a home for indigent persons of the Counties of Sarasota and Manatee, State of Florida; to solicit funds, receive donations and to disburse same for said purpose; to receive, manage, take and hold real and personal property by gift, grant, devise or bequest for the above-stated purpose; to purchase and own such real estate and other real and personal property as may be necessary to accomplish the above-set out purpose; to do any and all things necessary to maintain and operate said home and to care for the persons therein residing. The foregoing clauses shall be construed as objects, purpose and powers, and it is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the powers of this corporation now or hereafter conferred by law, except that any activity shall be in furtherance of it's not-for-profit, charitable purposes and defined under Section 501(c)(3) of the 1954 Internal Revenue Code, as amended."

2. The foregoing amendment was adopted by the Board of Directors, pursuant to the Certificate of Reincorporation, as amended, and the Bylaws of the undersigned corporation, on July 28, 1998. Members were not entitled to vote.
