



## EXHIBIT "A"

## AMENDMENTS REGARDING CORPORATE OWNERSHIP TO ARTICLES OF INCORPORATION OF THE PALM ROYAL APARTMENTS, INC.

Article IV. Section 8 of the Articles of Incorporation of the Association is hereby amended to read as follows:

Section 8.

In the event that any individual condominium parcel (apartment unit) is owned by more than one person, except husbands and wives, or by a corporation or other entity, the owners of the same shall execute and deliver to the Secretary of the corporation a certificate duly signed by all of the owners, or by the officers of the corporation or trustees, as the case may be, designating the person who shall be authorized to cast the percentage vote allocated to said individual condominium parcel (apartment unit). Such certificate shall be valid until revoked by a subsequent certificate. Unless said certificate is filed with the secretary of the corporation prior to the meeting at which said vote is to be cast, the vote of such owners shall not be considered for the purpose of determining a quorum or for any other purpose. Either the husband or wife who own a unit together may east the vote for that unit; provided, however if there is disagreement between them as to how the vote should be east, no vote for unit shall be counted. Notwithstanding anything herein to the contrary, no corporate ownership of a condominium parcel shall be allowed except in the event of an institutional mortgagee which became owner by foreclosure of a condominium parcel or by deed in lieu of foreclosure.
