CERTIFICATE OF INCORPORATION

1. The name of the Corporation shall be First Baptist Church of Bradenton, Florida, Incorporated.
2. The Purpose of the Corporation is preaching and teaching the Gospel of the Christian Religion and the support and upbuilding of the Kingdom of Jesus Christ through all customary agencies; and to take over, own and control such property, real and personal, as may be necessary or expedient for the use of said Church.
3. The Membership of this Corporation shall consist only of such persons as have publically professed their faith in the Lord Jesus Christ, who subscribe to the doctrines held by the denomination known as Missionary Baptist, and who have been admitted to membership by a majority vote of the Corporation present and voting; in such manner and under such regulations as shall be provided by the by-laws of the Corporation.

4. The term for which this Corporation is to exist shall be perpetually, unless sooner dissolved by law.

5. The names and residences of the subscribers are:

6. The affairs of the Corporation are to be managed and controlled by the majority of the membership present and voting at a conference of the Church, and by and through such officers, committees and agents as the Corporation may appoint, who at all times shall be subject to the will of the membership; and such officers, agents and committees shall not necessarily be appointed at any regular time nor for any definite period of time, and when no definite period is fixed by the order providing for the appointment, they shall hold at the will of the majority of the members present and voting at a conference of the Church. Provided, the Corporation cannot dispose of any of its real estate, except pursuant to a majority vote of a regular conference, upon a resolution introduced at a former regular conference.

Legal papers, contracts, conveyances and mortgages or other instruments required to be executed in the corporate name and capacity shall be executed in behalf of the corporation by the Chairman of the Board of Deacons as ex officio President of the Corporation, or in his absence by the vice Chairman of the Board of Deacons as ex officio Vice President of the Corporation, and the same attested by the Secretary of the Board of Deacons as ex officio Secretary of the Corporation, or by the Church Clerk, and documents so executed shall be binding upon the Corporation.

The following officers are to serve until the first election or appointment under the articles of incorporation:

10. Amendments to the articles of incorporation may be proposed at any church conference, and adoption of any amendment may be effected by a majority vote of the church membership present and voting at any church conference, at which the amendment has been proposed at the next preceding church conference. Bylaws of the corporation are to be made, altered or rescinded in the same manner.

These Articles of Incorporation constitute all the Articles of Incorporation and all amendments of the Corporation.

A petition having been filed from which it appears that certain desired amendments to Charter of First Baptist Church of Bradenton, Florida, have been authorized by the membership of said corporation by resolution as provided in the by-laws and present charter of said corporation, all subject to approval by the Circuit Judge, the court being advised in the premises:

It is Ordered, Adjudged and Decreed that the proposed amendments herein and the same hereby are approved, and that upon the recording of this order of approval, and the said charter of record in Corporation Book B page 309, public records of Manatee County, Florida, a certified copy thereof is granted in the following particulars, to-wit:

1. That said Charter be amended to read as follows:

The name of this corporation shall be First Baptist Church of Bradenton, and its location and principal place of business shall be in the city of Bradenton, County of Manatee, State of Florida.

2. That said Charter be amended to read as follows:

All the property of this corporation which now exists shall be held in trust for the purposes herein stated by law.

3. That article 11 of the Charter be amended to read as follows and additional paragraph be added to said article:

The Board of Directors may execute and mortgage or otherwise encumber any real estate owned in the corporate name of this corporation, and may execute in behalf of the corporation any instrument of the Board of Directors or any officer thereof, or the Corporation, or in his absence by any wife, partner or the Board of Directors as aforesaid, any instrument of the Corporation and any other instrument of the Board of Directors, or any officer thereof, or the Corporation, or by the Secretary of the Corporation, and all instruments so executed shall be binding upon the Corporation.

4. That article 12 of the Charter be amended to read as follows:

The Corporation may have and hold (subject always to the approval of the Circuit Judge) real estate to the value of Three Hundred Thousand (\$300,000.00) Dollars.
