## <u>Amended</u> Articles of Incorporation

#### ARTICLE I - NAME

The name of the corporation shall be "RIVIERA UNITED CHURCH OF CHRIST, Luc. which was formerly known as First Congregational Church of Melbourne, Brevard County, Florida, having been incorporated by a Circuit Judge on January 7, 1926. That all of the original incorporators are either deceased or their whereabouts unknown. That the name was changed to United Church of Christ (Congregational) on January 16, 1963. That the name was changed again to Riviera United Church of Christ, by a majority vote taken at a meeting of the church members on September 15, 2002. The address of the church for mailing annual reports is 451 Riviera Drive, Palm Bay, FL 32905; Post Office Box 62016, Palm Bay, FL 32906-2016.

#### ARTICLE III - MEMBERSHIP

The Membership in this corporation shall be composed of the present members of the Riviera United Church of Christ, formerly known as the United Church of Christ (Congregational), Inc., and as the First Congregational Church of Melbourne, Brevard County, Florida, and others who become members in accordance with the by-laws adopted by this corporation.

#### ARTICLE V - SUBSCRIBERS

The names and addresses of subscribers to this Charter and of the first officers, who shall serve until the next election thereof are as follows:

#### ARTICLE VI - OFFICERS

The financial and legal affairs shall be managed by a Church Council of not less than 15 members, who shall be elected by the members of this corporation at the annual meeting once a year in accordance with the by-laws of this corporation. The religious, educational and charitable affairs of this corporation shall be managed by the Moderator, together with the Church Council and such Committees as may be established in accordance with the by-laws of this corporation.

#### ARTICLE VII - FIRST OFFICERS

The officers of the corporation shall be as follows:

John McMorris, Vice-moderator
Giselle Aguiar, Clerk
Kent Bradley, Treasurer
Kay Martin, Financial Secretary

The Church Council shall have full power and authority to borrow money, make contracts, buy, sell, mortgage, and deal completely in and entirely with the real and personal property of this corporation, subject to the approval of the members of the corporation.

#### ARTICLE VIII - VESTED RIGHTS

Inasmuch as there is no stock issued in this nonprofit corporation, no incorporator or member of this corporation shall have any vested right, interest or priviledge to the assets of the corporation, unless it would be for money or material bought or money borrowed and notes signed by the Treasurer after being authorized by the Church Council or a majority vote of the members of said corporation.

#### ARTICLE IX - AMENDMENTS

The By-laws and amendments to the charter of this corporation shall be made and altered or amended or rescinded by the members of this corporation at any annual meeting or at a special meeting called for such purpose in accordance with the by-laws and a two-thirds vote of the members present.
