ARTICLES OF AMENDMENT
TO THE AMENDED AND RESTATED ARTICLES OF INCORPORATION OF
SARASOTA COMMUNITY BLOOD BANK, INC.

The undersigned, certifies that:

1. He is the President of SARASOTA COMMUNITY BLOOD BANK, INC., a Florida corporation, whose Articles of Incorporation were filed with the Secretary of State, State of Florida, on September 7, 1965, as amended.
