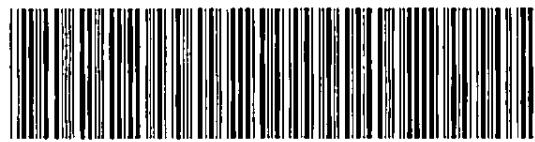

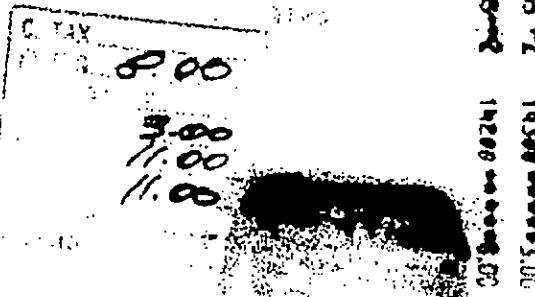

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves to form a corporation not for profit under the provisions of Chapter 617, Florida Statutes of 1963.

ARTICLE I

Name

The name of this corporation shall be PALM BEACH COUNTY BAR ASSOCIATION, INC.

ARTICLE II

Objects

The objects and purposes for which this corporation is organized are to promote and coordinate the work of The Florida Bar in Palm Beach County, to maintain the honor and dignity of the profession, to regulate the practice of and promote improvements in the law and the methods of its administration, to cultivate professional ethics and social intercourse among its members, and to discuss legal topics of general interest.

ARTICLE III

Membership

Section 1. The membership of the corporation shall constitute all those members of The Florida Bar of this County who are at the time of the adoption of these Articles of Incorporation members of the Palm Beach County Bar Association and all others who shall from time to time be elected and qualified as hereinafter provided.

Section 2. Any member of The Florida Bar in good standing, who is residing or practicing in Palm Beach County, who formerly resided or practiced in Palm Beach County, or who is a member of the armed forces stationed in Palm Beach County, shall be eligible for election to membership in this corporation.

Section 3. Admission to, or reinstatement of, membership in the corporation shall be on written application, with the endorsement of five sponsors thereon, said sponsors to be members of the corporation in good standing. The application shall be referred to

the Membership Committee, which shall interview the applicant and report to the corporation its recommendation at the following regular meeting. If the Membership Committee recommends the acceptance of the applicant, the approval by two-thirds of the members present at such regular meeting shall be necessary for membership in the corporation. However, if the Membership Committee's report on the applicant is unfavorable, the approval by three-fourths of the members present at such regular meeting shall be necessary for membership in the corporation. With such approval, the applicant shall become a member of the corporation, provided that such admission shall be subject to, and contingent upon, the payment of dues within ten days thereafter. Otherwise the action taken upon such application shall be void.

Section 4. Suitable dues of this corporation and the amount and manner of payment thereof, shall be prescribed by the By-Laws of the corporation.

Section 5. Any member of the corporation may be suspended or expelled for misconduct in his relationship to the corporation or his profession, or for nonpayment of dues after due notice thereof to said delinquent member in the manner prescribed by the By-Laws.

ARTICLE IV

Term

This corporation shall have perpetual existence.

Section 1. The affairs of this corporation are to be managed by a President, a President Elect, a Secretary, a Treasurer and three Directors who shall serve for one calendar year. Upon the expiration of each one year term the President Elect shall succeed to the office of President without election. The offices of President Elect, Secretary, Treasurer and Directors shall be filled by nomination and election from the membership at each annual meeting of the corporation. Election shall be by ballot and in the event of a contest for any office, election shall be by secret ballot.

Section 3. The President, President Elect, Secretary, Treasurer, and three Directors of the corporation, together with the President of the Junior Bar Section of the Palm Beach County Bar Association and the President of the South Palm Beach County Bar Association, ex officio, if they are members of this corporation, shall constitute the Executive Committee of this corporation.

Section 4. No person shall be eligible to hold the office of President of the corporation for two consecutive terms except that if the President shall fail to serve his full term and the President Elect shall assume the office of President in the absence of the President, the President Elect shall nevertheless be eligible to serve as President during the calendar year following the next annual meeting of the corporation.

ARTICLE VII

By-Laws

By-Laws may be adopted or amended by two-thirds vote of all members present at any regular meeting of the corporation or at any

special meeting called for that purpose, provided notice in writing of the wording of the proposed addition or amendment has been submitted to each member at least three days prior to said meeting. By-Laws may also be adopted or amended without notice by three-quarters vote of the members present at any regular meeting of the corporation.

ARTICLE VIII

Amendments to Articles of Incorporation

The Articles of Incorporation may be amended at any regular or regularly called meeting of the corporation by a three-quarters vote of the members present provided notice in writing of the wording of the proposed Amendment has been submitted to each member at least three days prior to said meeting.

ARTICLE IX

Recommendations

This corporation, as such, shall make no recommendations to any office of honor or profit except the Judiciary, The Florida Bar, and the American Bar Association.

4. Article V, Subscribers, shall be deleted in its entirety and replaced with the following:

ARTICLE V

Recommendations

This corporation, as such, shall make no recommendations to any office of honor or profit except the Judiciary, The Florida Bar, and the American Bar Association.

5. Article VI, Sections 1, 2, and 3 shall be deleted in their entirety and replaced with the following:

ARTICLE VI

Officers

Section 1. The affairs of this corporation are to be managed by President, President-Elect, Secretary and Treasurer, its Board of Directors consisting of its immediate Past President, the President of the Young Lawyers Section, the President of the South County Bar Association, the President of the North County Section, and three Directors at Large who shall serve for one fiscal year. All of such members shall as the Executive Committee. Upon expiration of each one-year term, the President-Elect shall succeed to the office of President without election. The offices of President-Elect, Secretary, Treasurer and Directors at Large shall be filled by nomination and election from the membership at each annual meeting of the corporation. Election shall be by ballot and in the event of a contest for any office, election shall be by secret ballot.

Further, Article VI, Section 4, shall be renumbered to Article VI, Section 2.

6. Article IX shall be deleted in its entirety.

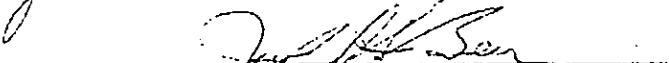

The Palm Beach County Bar Association, originally incorporated under the laws of the State of Florida, in 1965, desires to restate its Articles of Incorporation, with all prior amendments thereto. The original Articles of Incorporation were filed on September 17, 1965, and amended on March 9, 1973 and on July 26, 1977.

ARTICLE I

Name

The name of the corporation shall remain **PALM BEACH COUNTY BAR ASSOCIATION, INC.**

ARTICLE II

Objects

The objects and purposes for which this corporation is organized are to promote and coordinate the work of The Florida Bar in Palm Beach County, to maintain the honor and dignity of the profession, to regulate the practice of and promote improvements in the law and the methods of its administration, to cultivate professional ethics and social intercourse among its members, and to discuss legal topics of general interest.

ARTICLE III

Membership

Section 1. The membership of the corporation shall constitute all those members of The Florida Bar of this County who are at the time of the adoption of these Restated Articles of Incorporation members of the Palm Beach County Bar Association, Inc. and all others who shall from time to time be elected and qualified as hereinafter provided.

Section 2. Any member of The Florida Bar in good standing, who is residing or practicing in Palm Beach County, who formerly resided or practiced in Palm Beach County, or who is a member of the armed forces stationed in Palm Beach County, shall be eligible for election to membership in this corporation.

Section 3. Admission to or reinstatement of membership in the corporation shall be on written application, with the endorsement of two sponsors thereon, said sponsors to be members

of the corporation in good standing. The application shall be referred to the Executive Committee for approval. With such approval, the applicant shall become a member of the corporation, provided that such admission shall be subject to, and contingent upon, the payment of dues within ten (10) days thereafter. Otherwise the action taken upon such application shall be void.

Section 4. Suitable dues of this corporation and the amount and manner of payment thereof, shall be prescribed by the Bylaws of the corporation.

Section 5. Any member of the corporation may be suspended or expelled for misconduct in his relationship to the corporation or his profession, or for nonpayment of dues after due notice thereof to said delinquent member in the manner prescribed by the Bylaws.

ARTICLE IV

Term

This corporation shall have perpetual existence.

ARTICLE V

Recommendations

This corporation, as such, shall make no recommendations to any office of honor or profit except the Judiciary, The Florida Bar, and the American Bar Association.

ARTICLE VI

Officers

Section 1. The affairs of this corporation are to be managed by President, President-Elect, Secretary and Treasurer, its Board of Directors consisting of its immediate Past President, the President of the Young Lawyers Section, the President of the South County Bar Association, the President of the North County Section, and three Directors at Large who shall serve for one fiscal year. All of such members shall be known as the Executive Committee. Upon expiration of each one-year term, the President-Elect shall succeed to the office of President without election. The offices of President-Elect, Secretary, Treasurer and Directors at Large shall be filled by nomination and election from the membership at each annual meeting of the corporation. Election shall be by ballot and in the event of a contest for any office, election shall be by secret ballot.

Section 2. No person shall be eligible to hold the office of President of the corporation for two consecutive terms except that if the President shall fail to serve his full term and the President-Elect shall assume the office of President in the absence of the President, the President-Elect shall nevertheless be eligible to serve as President during the year following the next annual meeting of the corporation.

ARTICLE VII

Bylaws

Bylaws may be adopted or amended by two-thirds (2/3) vote of all members present at any regular meeting of the corporation or at any special meeting called for that purpose, provided notice in writing of the wording of the proposed addition or amendment has been submitted to each member at least three (3) days prior to said meeting. Bylaws may also be adopted or amended without notice by a three-quarters (3/4) vote of the members present at any regular meeting of the corporation.

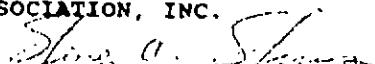

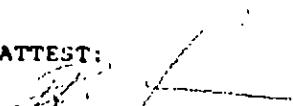

The Palm Beach County Bar Association, originally incorporated under the laws of the State of Florida, in 1965, desires to restate its Articles of Incorporation, with all prior amendments thereto. The original Articles of Incorporation were filed on September 17, 1965, and amended on March 9, 1973, July 26, 1977, and September 19, 1991.

ARTICLE I

Name

The name of the corporation shall remain PALM BEACH COUNTY BAR ASSOCIATION, INC.

ARTICLE II

Objects

The objects and purposes for which this corporation is organized are to promote and coordinate the work of The Florida Bar in Palm Beach County, to maintain the honor and dignity of the profession, to regulate the practice of and promote improvements in the law and the methods of its administration, to cultivate professional ethics and social intercourse among its members, and to discuss legal topics of general interest.

ARTICLE III

Membership

Section 1. Regular membership of the corporation shall constitute all those members of The Florida Bar who are at the time of the adoption of these Restated Articles of Incorporation members of the Palm Beach County Bar Association, Inc. and all others who shall from time to time be elected and qualified as hereinafter provided.

Section 2. Any member of The Florida Bar in good standing, shall be eligible for election to regular membership in this corporation.

Section 3. Affiliate membership shall also be available to all attorneys and judges who are in good standing in other states, although not members of the Florida Bar. Such affiliate members shall have no voting privileges nor shall they be permitted to hold office, be Directors or chair any committees.

Section 4. All regular members of the corporation shall also be members of the Legal Aid Society of Palm Beach County, Inc. and shall comply with the Articles and Bylaws of said corporation.

Section 5. Admission to or reinstatement of regular or affiliate membership in the corporation shall be on written application, with the endorsement of two sponsors thereon, said sponsors to be members of the corporation in good standing. The application shall be referred to the Board of Directors for approval. With such approval, the applicant shall become a member of the corporation, provided that such admission shall be subject to, and contingent upon, the payment of dues within ten (10) days thereafter. Otherwise the action taken upon such application shall be void.

Section 6. Suitable dues of this corporation and the amount and manner of payment thereof, shall be prescribed by the Bylaws of the corporation.

Section 7. Any regular or affiliate member of the corporation may be suspended or expelled for misconduct in his relationship to the corporation or his profession, or for nonpayment of dues after due notice thereof to said delinquent member in the manner prescribed by the Bylaws.

ARTICLE IV

Term

This corporation shall have perpetual existence.

ARTICLE V

Recommendations

This corporation, as such, shall make no recommendations to any office of honor or profit except the Judiciary, The Florida Bar, and the American Bar Association.

ARTICLE VI

Officers

Section 1. The affairs of this corporation are to be managed by President, President-Elect, Secretary and Treasurer, its Board of Directors consisting of its immediate Past President, the President of the Young Lawyers Section, the President of the South County Bar Association, the President of the North County Section, and three Directors at Large who shall serve for one fiscal year. All of such members shall be known as the Executive Committee. Upon expiration of each one-year term, the President-Elect shall succeed to the office of President without election. The offices of President-Elect, Secretary, Treasurer and Directors at Large shall be filled by nomination

and election from the membership at each annual meeting of the corporation. Election shall be by ballot and in the event of a contest for any office, election shall be by secret ballot.

Section 2. No person shall be eligible to hold the office of President of the corporation for two consecutive terms except that if the President shall fail to serve his full term and the President-Elect shall assume the office of President in the absence of the President, the President-Elect shall nevertheless be eligible to serve as President during the year following the next annual meeting of the corporation.

ARTICLE VII

Bylaws

Bylaws may be adopted or amended by two-thirds (2/3) vote of all members present at any regular meeting of the corporation or at any special meeting called for the purpose, provided notice in writing of the wording of the proposed addition or amendment has been submitted to each member at least three (3) days prior to said meeting. Bylaws may also be adopted or amended without notice by a three-quarters (3/4) vote of the members present at any regular meeting of the corporation.

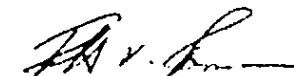

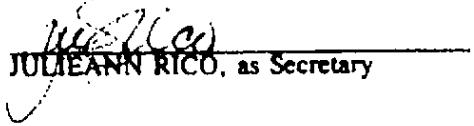
