The undersigned, being a majority of the current members of REDLANDS CHRISTIAN MIGRANT ASSOCIATION, INC., a non-profit corporation, hereby amends said corporation's articles of incorporation originally filed October 1, 1965, under the laws of the State of Florida as follows:

Article II of the original articles of incorporation shall be amended by deleting the existing language and replacing it with language to read as follows:

The purpose of this corporation shall be to promote the welfare of farm workers and other rural poor and their families throughout the State of Florida, through direct and indirect services, through cooperation with other public and private agencies and through the provision of opportunities of self-improvement, in order to promote health and better education, and to encourage individual self-sufficiency; and, to do any and all things permitted by law to be done by corporations not for profit under Chapter 617 of the Florida Statutes.

Article VIII of the original articles of incorporation shall be amended by deleting the existing language and replacing it with language to read as follows:

The affairs of this corporation shall be governed by a Board of Directors of not less than three (3) members. The members of the Board of Directors shall be all of the current members of the corporation from time to time.

In all other respects, the original articles of incorporation, whose document number is 709687, shall remain the same and were readopted and ratified in full.
