

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF PARK TOWER ASSOCIATION, INC. (Document Number 710812)



Pursuant to the provisions of Section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendments to its Articles of Incorporation:

Section 2(f) of Article III of the Articles of Incorporation is amended as follows (new words are underlined; deleted words are stricken):

(f) To make and amend reasonable regulation respecting the use of the property in the condominium; provided, however, that all such regulations and amendments thereto shall be approved by the affirmative vote of not less than seventy-five (75%) percent two-thirds (2/3) of the votes of the members of the Association present, in person or by proxy, at a duly called meeting of the entire membership of the Association where a quorum is present, in person or by proxy, and voting throughout, before such shall become effective. Failure of an owner or owners to approve an alteration or improvement so approved shall not relieve such owner or owners of their respective shares of the cost thereof.

The foregoing amendments were duly adopted by the affirmative vote of seventy-five percent (75%) or more of the members of the Association present, in person or by proxy, at a duly called meeting of the membership of the Association held on July 31, 2008, in accordance with the requirements of the Articles of Incorporation and the Bylaws of this Florida Not For Profit Corporation, and the number of votes cast for the amendments were sufficient for approval.


