# **AMENDMENTS:**

#### Amendment #1:

"The Board shall consist of an odd number of deacons (not less than 3 nor more than 7), and up to two alternate deacons. Immediate family members (i.e., spouses, parents, or siblings) shall not serve on the Board simultaneously, with the exception of the Secretary/Treasurer, who may function as an alternate deacon with voting privileges in the absence of a regular deacon.

#### Amendment #2:

"After serving in the position of Senior Pastor for a period of 20 years (September 16, 2020), a retirement income of \$500 shall be paid to Pastor Greg Bowen for the remainder of his lifetime. In the event that he is still actively serving as Pastor of Victory Life and Praise after 20 years, a retirement fund shall be established into which \$500 a month will be deposited which he will be eligible to collect upon his retirement. All aforementioned amounts shall be reevaluated at each annual business meeting to determine if they are eligible to be adjusted."
