ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

ISLAND HOUSE SOUTHEAST CONDOMINIUM ASSOCIATION, INC.

(Document Number 713562)

1. Sections A and B of Article IX of the Articles of Incorporation (Amendments) are hereby revised to read as follows:

(insertions are underlined, and deletions of prior language are struck-through)

"Amendments to the Articles of Incorporation shall be proposed and adopted in the following manner:

A. These Articles may be amended with the approval, either by written consent or by vote at a duly called meeting, of (i) a majority of the Board; and (ii) sixty-six percent (66%) of all of the votes in the Association. Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.

B. A resolution for the adoption of a proposed amendment-may be proposed either by the Board of Directors of the Association or by the members of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing such approval is delivered to the Secretary at or prior to the meeting. Except as elsewhere provided,

a. such approvals must be by not loss than 75% of the entire membership of the Board of Directors and by not loss than 75% of the votes of the entire membership of the Association; or

b. by not less than 80% of the votes of the entire membership of the Association."

2. THE FOREGOING AMENDMENT was adopted by not less than seventy-five percent (75%) of the Board of Directors and not less than seventy-five percent (75%) of the votes of the entire membership, pursuant to Article IX of the Articles of Incorporation, and the number of votes cast was sufficient for approval.
