ARTICLES OF CONSOLIDATION

WINSTON GATEWAY NO. 1 ASSOCIATION, INC., WINSTON GATEWAY NO. 2 ASSOCIATION, INC., WINSTON GATEWAY NO. 3 ASSOCIATION, INC., and WINSTON GATEWAY NO. 4 ASSOCIATION, INC., non-profit corporations under the laws of the State of Florida, hereby consolidate said corporations into a new non-profit Florida corporation under the name of WINSTON GATEWAY ASSOCIATION, INC.

The Articles of Incorporation of the new corporation are as follows:

ARTICLE I.

The name of this corporation shall be WINSTON GATEWAY ASSOCIATION, INC. Its principal office shall be located at 7900 - 9th Street North, in the City of St. Petersburg, County of Pinellas, State of Florida.

ARTICLE II.

The purpose for which this corporation is organized is:

- (a) To act as an "Association" as that term is defined in the Condominium Act (Chapter 711, Florida Statutes), and to act on behalf of its members collectively as their governing body with respect to the administration, maintenance, repair and replacement of a condominium to be known as WINSTON GATEWAY APARTMENTS CONDOMINIUM, located in Pinellas County, Florida, upon the following described lands:

COMMENCING at the Southeast corner of the Northeast 1/4 of Section 25, Township 30 South, Range 16 East, City of St. Petersburg, Pinellas County, Florida, run North 89° 46' 14" West 70.00 feet along the South line of the Northeast 1/4 of said Section 25 to a point on the West right-of-way line of 9th Street North; run thence North 0° 04' 09" East 135.00 feet along said West right-of-way line of 9th Street North to the point of beginning (P. thence along a curve to the left having a radius of 25.00 feet, an arc distance of 39.27 feet, a chord distance of 35.36 feet and a chord bearing of South 44° 46' 14" East to a point on the North right-of-way line of 77th Avenue North; run thence South 89° 46' 14" East, 263.42 feet along said North right-of-way line of 77th Avenue North; run thence North 56° 32' 22" East 18.03 feet along said North right-of-way line of 77th Avenue; run thence along said North right-of-way line of 77th Avenue North, South 89° 46' 14" East, 22.55 feet to a point designated as "Point 4"; continue thence along said North right-of-way line of 77th Avenue North, South 89° 46' 14" East, 102.42 feet; run thence along a curve to the left having a radius of 24.93 feet, an arc distance of 39.29 feet, a chord distance of 35.31 feet and a chord bearing of North 45° 08' 58" East to a point on the West right-of-way line of 9th Street North, the point of BEGINNING.

(b) To perform all the duties and functions of an "Association" set forth in the Condominium Act, as now existing or as the law may henceforth provide, except as limited by these Articles and the Declaration of Condominium, and all the powers and duties reasonably necessary to operate the condominium pursuant to the Declaration and as it may be amended from time to time, including but not limited to the following:

(1) To make and collect assessments against members as apartment owners to defray the costs, expenses and losses of the condominium.

(2) To use the proceeds of assessments in the exercise of its powers and duties.

(3) To maintain and repair the common elements of the condominium property.

(4) The purchase of insurance upon the condominium property and insurance for the protection of the Association and its members as apartment owners.

(5) The reconstruction of improvements after casualty and the further improvement of the property.

(6) To approve or disapprove the transfer, mortgage and ownership of apartments as may be provided by the Declaration of Condominium and the By-Laws.

(7) To enforce by legal means the provisions of the Condominium Act, the Declaration of Condominium, these Articles, the By-Laws of the Association and the Regulations for the use of the property in the condominium.

(8) To contract for the management of the condominium and to delegate to such contractor all powers and duties of the Association except such as are specifically required by the Declaration of Condominium to have approval of the Board of Directors or the membership of the Association.

(9) To contract for the management or operation of portions of the common elements susceptible to separate management or operation, and to lease such portions.

(10) To employ personnel to perform the services required for proper operation of the condominium.

(c) To exercise all the common law and statutory powers of a corporation not for profit not in conflict with the terms of these Articles.

ARTICLE III.

The members of this corporation, until the recording of the Declaration submitting the said property to condominium ownership, shall be the subscribers. From and after that time, the members shall consist of all the unit owners of WINSTON GATEWAY APARTMENTS CONDOMINIUM, in accordance with the respective percentages of ownership of the said unit owners in the common elements of the said property. Such respective percentages of ownership shall be determined in accordance with the provisions of the Declaration. Membership shall not be transferable, except as provided herein or in the Declaration. The membership of each unit owner shall terminate upon a sale, transfer or other disposition of his ownership interest in the property, accomplished in accordance with the provisions of the Declaration, and, thereupon, the membership shall automatically transfer to and be vested in the new owner succeeding to such ownership interest. This corporation may, but shall not be required to, issue certificates or other evidence of membership therein. All members of the corporation shall be subject to all the rules, regulations, constitutions and By-Laws hereinafter adopted by it, and to the provisions of the Declaration.

ARTICLE IV.

This corporation shall have perpetual existence. ✓

The affairs and business of this corporation shall be conducted by a Board of Directors of the corporation, and a President, who shall be a Director, one or more Vice-Presidents, a Secretary, a Treasurer, and such assistants to such officers as the Board of Directors may deem appropriate.

ARTICLE IX.

The By-Laws of the corporation are to be made by the Board of Directors initially, and thereafter may be amended, altered, modified or rescinded by the action or approval of a majority of the unit owners; except the By-Laws affecting the rights or interests of the developer of the condominium property shall not be amended or modified without the written consent of the developer. The manner of altering, modifying, amending or rescinding the By-Laws shall be provided for in the By-Laws.

ARTICLE X.

Amendments to the Articles of Incorporation shall be adopted by a two-thirds (2/3rds) vote of the Board of Directors at any duly constituted meeting, and proposed by the Board of Directors to the membership. A two-thirds (2/3rds) vote of all members present entitled to vote at a duly constituted meeting of the membership shall be necessary to

change in the qualifications for membership without approval of a majority of all members and the joinder of all record owners of mortgages upon the condominium. No amendment shall be made that is in conflict with the Condominium Act of the State of Florida or the Declaration of Condominium.

ARTICLE XI.

(a) Directors shall be elected from among the unit owners or if a unit owner shall be a corporation, partnership or trust, then an officer, partner or beneficiary of such unit owner may qualify as a director. If a director shall cease to be a unit owner, he shall cease to be a director. Directors shall be elected initially so that the terms of no more than one-third (1/3) of the directors shall expire in any one year. The directors shall hold office until their successors have been elected and qualified. If the number of directors shall be increased, the terms of such additional directors shall be fixed so that the terms of at least one-third (1/3) of the persons on the Board shall expire annually. Vacancies on the Board of Directors caused by any reason, including the failure of a director to continue to meet the qualifications of office, shall be filled by election by the members at the next annual meeting or at a special meeting called for such purpose.

meeting of the Board of Directors and shall hold office at the pleasure of the Board. Any officer may be removed at any meeting by the affirmative vote of the majority of the members of the Board of Directors either with or without cause, and any vacancy in any office may be filled by the Board at any meeting thereof.

(c) The powers of the corporation shall be subject to and shall be exercised in accordance with the provisions of the Declaration of Condominium, these Articles of Incorporation, and the By-Laws.
