#### FINAL ORDER GRANTING PERMANENT INJUNCTION

This Cause came on for hearing on the 28th day of August, 2008, and the Court having considered the testimony and documentary evidence presented, the argument of counsel, and being otherwise duly advised in the premises, the Court makes the following findings:

- 1. That the Defendant, Leon Lee, has been terminated from his position as pastor of the Taft Missionary Baptist Church, hereinafter "Church".
- That the incorporation by the Defendants, LEON LEE and CARVIN JONES, on April 14,
   2008 of the "Taft Missionary Baptist Church, Inc." was without the authority of the congregation or the governing board of the Taft Missionary Baptist Church.

It is therefore

#### ORDERED and ADJUDGED as follows:

 That the a Permanent Injunction is hereby entered directing the Defendants, Leon Lee and Carvin Jones, to return any property of the Church in their possession, including any keys to the church property located at 123 Pine Street, Orlando, Florida, and that Defendant, Leon Lee, shall not enter on said property except for the sole purpose of obtaining his pastor robe and books.

- That when retrieving his property, Defendant, Leon Lee, shall be accompanied by a member of the church which shall be coordinated by the parties' attorneys.
- 3. That the Defendant, Leon Lee and Carvin Jones, shall immediately dissolve the Corporation filing by them on April 14, 2008 with the name Taft Missionary Baptist Church, Inc., and shall not file any request for a corporation with this name.
