### To Whom It May Concern:

Please find enclosed a completed corporation reinstatement form for the above referenced non-profit entity. Also attached is a check for \$306.25, which represents the annual report fee for 1997-2001.

We request a waiver of the reinstatement fee normally charged in the amount of \$175.60. There is no record in our files of ever receiving the renewal form necessary to renew our status since 1997. The current Board of Directors only became aware of the administrative dissolution today. Compliance efforts began immediately because we are very concerned and want to rectify the situation without delay.

Our organization operated within a very tight budget in an effort to serve the youth of our community by providing a quality football and cheer program through the nationally recognized Pop Warner rules and regulations. The annual report fees are unbudgeted but absolutely necessary and that is why it is enclosed. However, to help alleviate any additional hardship to our program for young people, we ask that we be relieved of the requirement to pay the additional fee. We have taken action to include the annual fee of \$61.25 in future budgets so that this oversight will not occur again.
