## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SPRING LAKE TOWERS MANAGEMENT, INC



Pursuant to the provisions of §617.1006, *Fla.Stat.*, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

## FIRST: Amendment(s) adopted:

1. Article X, Section 1 of the Articles of Incorporation of Spring Lake Towers Management,
Inc., is hereby amended as follows:

## ARTICLE X

## Amendment of Articles of Incorporation

Section 1. Any ten (10) members of the corporation may propose amendments to the Articles of Incorporation, provided, however, that an affirmative vote of eighty-five percent (85%) fifty-three (53) or more of the qualified Voting Members of the corporation shall be necessary to adopt such proposed amendments.

SECOND: The date of adoption of the Amendment was 12/6, 2000.

THIRD: Adoption of Amendments

FOURTH: The number of votes cast for the amendment was sufficient for approval.
