

ADOPTED AMENDMENT TO THE ARTICLES OF INCORPORATION OF WAVERLY TOWERS ASSOCIATION. INC.

The following is an adopted amendment to the Articles of Incorporation of Waverly Towers Association, Inc., which is attached as an exhibit to the original Declaration of Condominium Ownership, originally recorded at Official Records Book 3633, Page 237, Public Records of Pinellas County, Florida.

(New Wording <u>Underlined</u>; Deleted Wording Stricken Through, Except When Proposed Amendment Involves Substantial Rewording)

Item No. 3: Article IX, Section 2 of the Articles of Incorporation is hereby amended to read as follows:

ARTICLE IX

Amendments to the Articles of Incorporation shall be proposed and adopted in the following manner:

- (2) A resolution for the adoption of a proposed amendment may be proposed either by the board of directors or by a petition signed by at least thirty-three percent (33%) of the members of the Association who are entitled to vote. Any amendments proposed by the members are subject to editing as to form and legality by legal counsel for the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, provided such approval is delivered to the secretary at or prior to the meeting. Except as elsewhere provided.
- (e) Such approvals must be by not less than 75% of the entire membership of the board of directors and by not less than 75% of the votes of the those members who are entitled to vote and who participate in the voting at a membership meeting, on this issue, in person or by proxy, entire membership of the Association; or
- (b) By not loss than 80% of the votes of the entire membership of the Association.
