# CHANGES TO THE CHARTER FOR INCORPORATION of SEMINOLE CHRISTIAN FELLOWSHIP, INCORPORATED Seminole, FL

#### ARTICLE II PURPOSE

Item B shall be changed to read as follows:

B. For the purpose of executing deeds, mortgages, notes, leases, or other instruments affecting the transfer or encumbrance of real estate or any interest of the corporation therein, the Chairman of the Administrative Board of the congregation shall be, and at all times is, the President of the Corporation, and the Secretary of the Administrative Board shall be, and at all times is, the Secretary of the Corporation, and such persons are at all times authorized to act as such. The signatures of both the Chairman and the Secretary are required to transact business.

### ARTICLE III MEMBERSHIP

Article III shall be changed to read as follows:

The membership of this corporation shall consist of those followers of Jesus Christ who are now identified as members of the corporation; and those who shall unite with the corporation coming on the confession of their faith in Jesus Christ as Savior. Furthermore, those who wish to be received as members of Seminole Christian Fellowship, Inc. must complete a request for membership card, meet with the Senior Pastor and/or representatives from the Elder Board, and be introduced to & received into fellowship by the existing members of the congregation.

Henceforth, those who are members of the corporation shall be referred to as "the congregation." When reference is made to "the corporation" it will refer to members of the corporation/congregation and to no others.
