## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION FOR FOR FOR

THE BERKLEY SOUTH CONDOMINIUM ASSOCIATION, INC.

Pursuant to the provisions of Section 617.1006, Florida Statutes, the undersigned corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment adopted:

Article XII of the Articles of Incorporation is amended to read:

These Articles of Incorporation may be altered, amended, changed, added to or repealed, in the manner now or hereafter prescribed by statute, or herein or by the By-Laws of this Corporation as they exist from time to time or the said Declaration of Condominium, in one of the following three (3) manners: (i) at any duly called meeting of the Members of this corporation and approved by an affirmative vote of at least a majority of the Members present in person or by proxy provided there is a quorum, and further provided that notice of the meeting is given in the manner provided for in the Articles of Incorporation any By-Laws of this Corporation, and that the notice contains a full statement of the proposed alterations, amendment, change, addition or repeal of any provision of these Articles: (ii) by the written consent of a majority of voting interests voting by written consent, provided that at least a majority of voting interests submit written consents; or (iii) at a duly convened meeting of the Members and approved by a combination of written consents and votes totaling not less than the minimum number of votes that would be necessary to authorize or take such action at a meeting, provided there is a quorum, and further provided that the notice of such meeting of Members specifying the proposed change is given in the notice of meeting. If action by written consent is utilized in conjunction with a meeting, no written consent is effective to take the action referred to therein unless such written consent is delivered to the Association at, or before the date of, the meeting. Written consents count towards the quorum., and that at such meeting there is an affirmative vote of two-thirds (2/3) of the voting interests present in person or by proxy in favor of said alteration, amendment, change, addition or repeal, but in no event shall these Articles of Incorporation be altered, amended, changed, added to or repealed to impair, amend, rescind, cancel or conflict with any contract or document entered into by the Corporation and which document or instrument is made a part of or referred to in these Articles of Incorporation except with the consent in writing of the contracting party.
