#### **ARTICLE VII**

### **AMENDMENT OF ARTICLES OF INCORPORATION:**

Amendments to those Articles of Incorporation may be proposed and adopted as follows:

An Amendment may be proposed by either the Board of Directors or by twenty-five percent of the voting interests.

The Amendment must be approved by a vote of two-thirds (2/3rds) of the voting interests of the Corporation Association present (in person or by proxy) and voting at a duly noticed meeting at which a quorum is present.
