AMENDMENT TO THE ARTICLES OF INCORPORATION of THE DUNES CLUB ASSOCIATION, INC. (A Condominium Association)

The Articles of Incorporation of The Dunes Club Association, Inc., were filed with the Florida Secretary of State on June 30, 1972 and an amendment filed on January 6, 2003. The same Articles of Incorporation and amendment were recorded in the Official Records of Martin County, Florida at Official Records Book 343, Page 2448, et.seq. and an amendment was recorded at OR Book 1717, Page 2584, et. seq. The same Articles of Incorporation are hereby amended as approved by the membership by vote sufficient for approval at a Special Members' Meeting held on March 24, 2003.

1. Article V is amended to read as follows:


