

ARTICLES OF INCORPORATION

We, the undersigned, hereby make, subscribe, acknowledge, and file this certificate for the purpose of becoming a corporation not for profit under the laws of the State of Florida.

SECTION I. The name of this corporation not for profit shall be the KIDS INCORPORATED OF THE BIG BEND.

SECTION II. The general purposes for which this corporation not for profit shall be:

- a. To provide, expand and upgrade child care, childhood education and associated services for children and their families collaboratively with community partners.
- b. To engage parents and legal guardians as partners in decisions regarding the care and education of their children.
- c. To develop community support for coordinated quality early education and care, and associated services for children and their families.
- d. To provide education and professional development opportunities for staff and community partners in child care, childhood educations, family support and related services.

SECTION III. This corporation not for profit shall have perpetual existence.

The Board of Directors shall be comprised of any person interested in the objectives and mission of Kids Incorporated. No person who is an employee or receives direct remuneration from Kids Incorporated may be a voting member of the Board of Directors.

SECTION VI. The powers of the executive officers shall be determined by the Board of Directors.

SECTION VII. The By-Laws of this corporation not for profit may be altered, revised or repealed and new by-laws may be adopted by the Board of Directors at any regular or special meeting of the Board called for the purpose, by a simple majority vote of the Board, present and voting, providing that a quorum is present, and provided further that the proposed amendment(s) shall have been introduced, read and entered in the minutes of the preceding regular meeting.

SECTION VIII. Amendments may be proposed by any member of the Board of Directors and shall become part of these Articles of Incorporation upon two-thirds vote of the total membership of the Board of Directors.

SECTION VIIII. Programs of this corporation not for profit shall be carried out without regard to race, sex, for national origin and shall comply fully with state and federal laws.
