This morning, I made a call to Kristen in your office about why our entire packet was sent back to us. I just could not believe that the whole packet was returned to us in order to have a signature placed at the bottom of the page. In the process, and in the meeting of our directors, which was going on at the same time, we discovered some minor changes which we wished to have made in the REINSTATEMENT DOCUMENT.

In view of the information contained in the above paragraph, I am taking the liberty of altering Document 724212 and returning a number of them to reflect those changes.

In the following notes as to Block items, I am giving Block item changes and where appropriate, the reasons for the changes.

Block 7 The name of Mrs Frank Ostanik is changed to Susan M. Ostanik. In view of the fact that Susan will become our new Registered Agent as well as the new Secretary-treasurer and a Director as well. (STD) I do not right now have the cost of changing Registered Agents, but I believe that there was a separate charge for making a change of Registered Agents. I will include another check for this charge if it is still applicable. If it is no longer applicable, send it back.

Block 10. The name of Mrs. Lee Metema is changed to KAREN SIMS Metema. This is not a change of persons. KAREN SIMS METEMA and MRS LEE METEMA are the same person. KAREN WILL remain a Director of the Corporation. A corrected address is shown.

Block 11. W J CROSBY will no longer remain the Registered Agent or the Secretary-treasurer, as these duties will pass on to SUSAN M Ostanik after April 10, 2006. W J CROSBY will remain the Secretary-treasurer until April 10, 2006 in order to effect the check signature cards for these two checks enclosed in this reinstatement request. W J CROSBY will still remain a director. A corrected address is shown for him.

Block 10. I have used the delete feature of Block 10. KAREN MEDEMA is added at the same time that MRS. LEE MEDEMA IS deleted.

Block 8. As has been mentioned in Block 7 above, Susan M. Ostanik becomes the new STD on April 10, 2006 by which time I will have her name on a new signature card at the bank.

I hope that I have submitted this REINSTATEMENT acceptable to you. I am submitting our check for the \$122.50 and another for \$20.00 for the change of STD. If this is not right I will send you some more.

Unless my memory has completely gone, it tells me that I wrote this division notifying you that I had never received a packet for sending in the 2005 report and I asked to be sent a copy of the reporting packet. This same memory tells me that I never did get such a thing.

Since the Citra Improvement Society has sort of been rejuvenated and is doing very well now. we are attempting to restore the old Bank of Citra building to be used as a museum. We have installed a new roof with steel truss-work and have new period windows built. We have quite a lot of trinkets and stuff being saved by old timers.

We know that we did not send in the \$61.25 which would have accompanied the 0005 corporation and now there will be the 0006 report. Please let me know what I can do to make our corporation reports current.

We have some difficulties with respect to Marion County firemen and rescue personnel. They or at least, the County have the use of our building for \$1.00 per year, and our community is a much finer place to live knowing that personnel of their education and experience are so very close, but there isn't much comraderie between the firemen and the rest of the community.

I stand ready to send you two checks for \$61.25 each and to accomplish annual reports. Please let me know soon. I AM 79 YEARS OLD AND would like to finish it before someone ~~else~~ gets hold of the report and probably never would get it accomplished.

I would like to suggest that such packets be sent to me rather than to the Fire station box and this thing go for another round.

Gentlemen,

Since I have reached the ripe old age of 79, I feel that I am writing this letter for the last time. The charter of the Citra Improvement Society and Volunteer Fire Department, Inc. I found out only yesterday had been dissolved (I found out only yesterday at the same time that I received your letter from our president) That had come about because I never received the packet with instructions for filing the 2005 renewal from the Florida Department of State. We have a Post Office Box but for several years the box has not been serviced daily by the firemen of the Marion County Fire Department and do not take kindly to instructions by the Corporation to do a few things because they live in the Citra Fire Station, but are paid by the Marion County Fire Department. I am going to explain to you how this has come to pass]

Some thirty years ago, some local men decided to form a volunteer fire department. There was no funding and so the volunteers canvased local businessmen for donations and staged bar-b-que for funds once a year to buy fuel, parts, and hoe handles, because the Florida Forest had donated a couple of trucks which had been donated to them by the Federal Defence Department. We raised each year about \$4000.00. We had no insurance nor firemen's clothing and most of the 26 volunteer fire departments sought some help from Marion County Commissioners who were not financially able nor inclined to provide any assistance. The volunteers sought help from commissioners who were sympathetic but not at that time authorized to help them.

Congress became aware of the problem, which was really nationwide and passed legislation that that echelon of gov't. closest to the people should provide fire prevention and supression. This meant that County Government would have to provide fire services to people living out in the counties. Rescue and emergency medical services soon followed, as companion services to fire service.

It is relatively easy to see how personnel trained in emergency medicine and fire service ~~service~~ see how picking up the mail can be regarded as demeaning, and the local fire service officers were Subjects of the Marion County Fire and Rescue. members of the Volunteer Fire Department only helped out in the event of a fire or rescue call. Mail stacked up in the Post Office box for weeks. At this time, I cannot see how the problem will be solved out into the future, except that I will not be a partner in its solution.

In view of the above, it seems useless to that it is ridiculous for a little outfit like ours to be expected to file a Form 990, and if such is required, send us a form.

I am accomplishing the Form which was sent to us and attaching it as an inclosure.
