**WHEREAS**, the Amended and Restated Articles of Incorporation of Boca West Master Association, Inc., formerly known as Boca West Maintenance Association, Inc. was recorded in the Public Records of Palm Beach County, Florida in Official Records Book 7690 at Page 60 et. seq. of the public records of Palm Beach County, Florida;

**WHEREAS**, Article XI of the Articles of Incorporation provide that they may be amended in the same manner as the Bylaws of the Association may be amended pursuant to Article IX of the Bylaws;

**WHEREAS**, consistent with the requirements of Article IX, Section 1 of the Bylaws, in excess of 4 directors adopted a resolution setting forth the proposed amendment and directed that it be submitted to a vote at a meeting of the members. 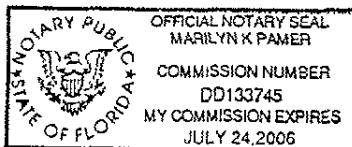

Proposed Amendment to Article I, Paragraph 1 of The Amended  
And Restated Articles of Incorporation of  
Boca West Master Association, Inc.

Article I, Paragraph 1 shall be amended as follows: (Additional language is underlined and stricken language is overstricken)

1. "Alternate Authorized Representative" means the Lot Owner designated by a Member to represent such Member at Meetings of the Members of the Association and cast votes on behalf of such Member in the event the Authorized Representative is not present in person or by proxy. Such designation shall be evidenced by the most recent written designation executed by the President or Vice President of such Member, which is filed with the Association. In the event a written designation is executed by the President of a Member and a separate written designation is executed by the Vice President of a Member, then the designation executed by the President shall control. An Alternate Authorized Representative must be an officer or director of the Member which designates him or her as an Alternate Authorized Representative at the time of such designation. If subsequent to such designation such Alternate Authorized Representative ceases to be an officer or director of the Member which has designated him or her, such person may continue to serve as an Alternate Authorized Representative unless the Member designates a new Alternate Authorized Representative which the Member may do at any time. Any Alternate Authorized Representative who ceases to be a Lot Owner shall automatically be deemed to have resigned such position. Notwithstanding that the foregoing provides that an Alternate Authorized Representative must be a Lot Owner, the spouse of a Lot Owner shall also be eligible to serve as an Alternate Authorized Representative if appointed as provided herein.

Proposed Amendment to Article I, Paragraph 6 of The Amended  
And Restated Articles of Incorporation of  
Boca West Master Association, Inc.

Article I, Paragraph 6 shall be amended as follows: (Additional language is underlined and stricken language is overstricken)

1. "Authorized Representative" means the Lot Owner designated by a Member to represent such Member and cast votes on behalf of such Member in person or by proxy at meetings of the Members of the Association as evidenced by the most recent written designation executed by the President or Vice President of such Member, which is filed with the Association. In the event a written designation is executed by the President of a Member and a separate written designation is executed by the Vice President of a Member, then the designation executed by the President shall control. An Authorized Representative must be an officer or director of the Member which designates him or her as an Authorized Representative at the time of such designation. If subsequent to such designation such Authorized Representative ceases to be an officer or director of the Member which has designated him or her, such person may continue to serve as an Authorized Representative unless the Member designates a new Authorized Representative which the Member may do at any time. Any Authorized Representative who ceases to be a Lot Owner shall automatically be deemed to have resigned such position. Notwithstanding that the foregoing provides that an Authorized Representative must be a Lot Owner, the spouse of a Lot Owner shall also be eligible to serve as an Authorized Representative if appointed as provided herein.
