A resolution approving a proposed Amendment may be proposed by either the Board of Directors or by the membership of the Association, and after being proposed and approved by any of such bodies, it must be submitted for approval and thereupon received such approval by the other. Such approval must be by seventy-five (75%) sixty-six and two-thirds (66-2/3%) percent of the members of the Association; and such approval must be by two-thirds (2/3) a majority of the members of the Board of Directors.
