**AMENDMENT TO THE ARTICLES OF INCORPORATION  
OF VILLAGE ROYALE GREENSIDE ASSOCIATION, INC.**

Article VIII

\* \* \*

2. The Board of Directors shall elect the President, Secretary and Treasurer and as many Vice Presidents, Assistant Secretaries and Assistant Treasurers as the Board of Directors shall, from time to time, determine. The President and Vice President shall be elected from among the membership of the Board of Directors, but no other Officer need ~~be~~ a Director. In addition, the President must reside in the Condominium for at least eleven (11) months in each calendar year. The ~~S~~same person may hold two offices, the duties of which are not incompatible; provided, however, the office of President and Vice President shall not be held by the same person, nor shall the office of President and Secretary or Assistant Secretary be held by the same person.
