ADOPTED AMENDMENT TO THE ARTICLES OF INCORPORATION OF WINSTON PARK NORTHEAST 300/400 ASSOCIATION, INC.

Article XII, Section (a) is amended to read as follows:

(a) Directors shall be elected from among the unit owners. If a unit owner shall be a corporation, partnership, or trust, then an officer, agent, partner or beneficiary of such unit owner may qualify as a director. If a director shall cease to be a unit owner, he shall cease to be a Director. Directors shall be elected initially so that the terms of no more than one-third (1/3) of the Directors shall expire in any one year. Directors shall hold office until their successors have been elected and qualified. If the number of directors shall be increased, the terms of such additional directors shall be fixed so that the terms of at least one-third (1/3) of the persons on the Board shall expire annually.
