# AMENDMENT TO THE ARTICLES OF INCORPORATION OF ORIOLE GARDENS CONDOMINIUM ASSOCIATION, INC.

# TO THE ARTICLES OF INCORPORATION

# ARTICLE VII

# **OFFICERS**

The affairs of the Association shall be managed by the President of the Association, assisted by the several Vice Presidents, Secretary and Treasurer, and, if any, by the Assistant Secretary and Assistant Treasurer, subject to the directions of the board. The Board, or President, with the approval of the Board, may employ a Managing Agent and/or such other managerial and supervisory personnel or entities to administer or assist in the administration of the operation or management of this Association.

The Board shall elect a President, Vice President, Secretary, and Treasurer, and as many Vice Presidents, Assistant Secretaries and Assistant Treasurers as the Board shall, from time to time, determine. The President and Vice President shall be elected from amongst the membership of the Board, but no other officers need be a director.

#### ARTICLE IX

## **BOARD OF DIRECTORS**

3. The affairs of the Association will be managed by a Board of seven (7) Directors. Directors of the Association shall be appointed or elected at the Annual Members' Meeting in the manner set forth in the By-Laws. Membership of all Boards elected subsequent to the First Board shall be composed of the following:

- A. There shall be two (2) Directors elected by each class of members, each of whom shall be a resident and Apartment Owner of the Oriole Gardens Condominium electing such Director.
- B. If a resident of a condominium operated and maintain buy Oriole Gardens Condominium Association, Inc. is not an owner of the unit, he may be considered an apartment owner for the purpose of being elected to the Board of Directors if and only if all of the record title owners of the unit execute a full power of attorney to the resident which grants to the resident all of the rights and obligations that the unit owner possesses by virtue of being a unit owner. Such power of attorney shall not in any way release the unit owner from his obligations arising under any statute or documents, including, but not limited to, the Declaration of Condominium, Articles of Incorporation, By-laws, Rules and Regulations and Florida Statutes, Chapter 718, as may be amended from time to time. Said power of attorney must be on file with the Secretary of the Association before any resident is eligible to be nominated for a seat on the Board of Directors. Further, in order for a resident to be elected by a class of voters, he or she must be a resident of the Oriole Gardens Condominiums electing such Director, and if said resident is not a unit owner, the grantors of the power of attorney must be record title owners of the unit in the Oriole Gardens Condominium electing such Directors.
- C. Notwithstanding the above, this section shall not apply to lessees, renters or tenants of units. A renter, tenant or lessee may not serve on the Board of Directors.
- 4. The first election by the members of the Association for Directors shall not be held until after Oriole Homes Corp. Or its successors or assigns (the "Developer") has relinquished control of the Association as described in paragraph 5 of this Article IX. Thereafter, the election of Directors shall take place annually within fifteen (15) days subsequent to the Annual Members' Meeting in accordance with Section 3.2(b) of the By-Laws.
