AMENDMENT TO THE ARTICLES OF INCORPORATION OF CASA DEL REY CONDOMINIUM ASSOCIATION, INC.

(Additions shown by underlining; deletions shown by "---")

- 1. Amendment to Article THREE(2)(h) of the Articles of Incorporation to provide as follows:
 - " h. To contract for the management of the condominium and to delegate to such contractor all powers and duties of the Association except such as are specifically required by the condominium documents to have approval of the Board of Directors of the membership of the Association. These contracts shall be granted on a yearly basis and for a proper consideration. Notwithstanding anything contained herein to the contrary, the Association shall only contract for the management of the condominium after a majority of the unit owners approve a proposal for such management in advance."
