**ARTICLES OF AMENDMENT TO
AMENDED AND RESTATED ARTICLES OF INCORPORATION OF
LITTLE HAVANA ACTIVITIES & NUTRITION
CENTERS OF DADE COUNTY, INC.**
(a Florida corporation not for profit)

Pursuant to the provisions of Fla. Stat. 617.1006, the Amended and Restated Articles of Incorporation of Little Havana Activities & Nutrition Centers of Dade County, Inc. are hereby amended as follows:

1. Article II, Purpose, is amended effective immediately by adding the following after section (f) of Article II:


(g) The provision of affordable housing to very low income, low income and moderate income persons.

(h) Any other purpose permitted by law.
