Enclosed is a check in the amount of \$87.50 to process this change and for the cost of one certified copy. If further information is needed please do not hesitate to contact me.

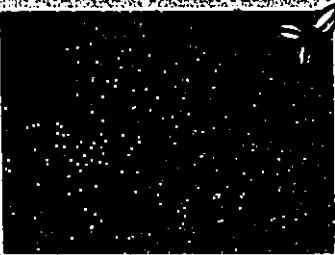
